**AMENDMENT TO H.R. 1**

**OFFERED BY MR. SCHOCK OF ILLINOIS**  
*and Mr. Smith of Washington*

Page 17, after line 10 (after section 1201(b)(1)(B)),

insert the following:

1 (vii) In the case of State or local  
2 agency, a unique identifier, which is con-  
3 sistent from Federal appropriation through  
4 expenditure, for all funds obligated,  
5 projects solicited, contracts awarded, and  
6 subcontracts.

7 (C) The notification required by subpara-  
8 graph (A) shall include requirements for timely  
9 notification as follows:

10 (i) For obligations, notification post-  
11 ing must occur no later than 30 days after  
12 obligation.

13 (ii) For contracts, notification posting  
14 must occur no later than ~~30~~ days after  
15 contract award. 45

16 (iii) For subcontracts larger than  
17 \$100,000, notification posting must occur  
18 no later than ~~30~~ days after subcontract  
19 award. 60

Page 17, strike lines 19 through 25 (subsection (c) of section ~~1202~~<sup>1201</sup>) and insert the following:

1       (c) Each obligation, solicitation issued, contract  
2 awarded, or grant issued using funds made available in  
3 this Act shall be posted on the Internet with the unique  
4 identifier required in subsection (b)(1)(C) and linked to  
5 the website Recovery.gov. Proprietary data required to be  
6 kept confidential under applicable Federal or State law or  
7 regulation shall be redacted before posting.

Page 25, strike lines 6 through 12 (paragraph (4) of section 1226(c)) and insert the following:

8       (4) The website shall provide detailed data on  
9 funds obligated and contracts awarded by Federal,  
10 State, or local agencies for purposes of carrying out  
11 this Act, including information about the competi-  
12 tiveness of the contracting process, notification of  
13 solicitations for contracts to be awarded, contractor  
14 and subcontractor recipients of funds (including any  
15 recipients that are minority, disadvantaged, or vet-  
16 eran-owned businesses) and information about the  
17 process that was used for award of contracts.

Page 25, strike lines 13 through 15 (paragraph (5) of section 1226(c)) and insert the following:

1           (5) The website shall include real-time, print-  
2           able reports on funds made available in this Act that  
3           are obligated to each State, congressional district,  
4           county, municipality, or other public entity, and, for  
5           specific expenditures made under each obligation,  
6           the details of contractors, subcontractors, and ex-  
7           pected start date of projects.

Page 25, after line 21 (at the end of section 1226),  
insert the following:

8           (d) IMPLEMENTATION.—The Recovery.gov website  
9           and capabilities described under subsection (c) shall be in  
10          place no later than ~~30~~ days prior to obligating any funds  
11          under this Act.       60
