(SUPPLEMENTAL APPROPRIATIONS)
OFFERED BY MR. ROGERS OF KENTUCKY

In chapter 10 of title II, in the item relating to “Global Health and Child Survival”, after the first and third dollar amounts, insert “(reduced by \$50,000,000)”.

In chapter 10 of title II, in the item relating to “Economic Support Fund”, after the first and last dollar amounts, insert “(reduced by \$126,500,000)”.

In chapter 10 of title II, in the item relating to “Nonproliferation, Anti-Terrorism, Demining and Related Programs”, after the first and second dollar amounts, insert “(reduced by \$23,500,000)”.

After title II, insert the following new title (and redesignate the subsequent title and sections accordingly):

- 2 BORDER VIOLENCE
- 3 CHAPTER 1—DEPARTMENT OF JUSTICE
- 4 GENERAL ADMINISTRATION

- 7 \$15,000,000.

21 SALARIES AND EXPENSES

22 For an additional amount for "Salaries and Ex-
23 penses", \$12,200,000, of which \$4,000,000 shall remain
24 available until September 30, 2010.

1 CONSTRUCTION

2 For an additional amount for "Construction" for in-
3 frastructure costs related to outbound inspections at ports
4 of entry, \$15,000,000, to remain available until expended.

5 U.S. IMMIGRATION AND CUSTOMS ENFORCEMENT

6 SALARIES AND EXPENSES

7 For an additional amount for "Salaries and Ex-
8 penses", \$52,800,000, of which \$16,320,000 shall remain
9 available until September 30, 2010.

10 COAST GUARD

11 OPERATING EXPENSES

12 For an additional amount for "Operating Expenses"
13 for immediate cutter maintenance needs, \$10,000,000, to
14 remain available until September 30, 2010.

15 FEDERAL EMERGENCY MANAGEMENT AGENCY

16 STATE AND LOCAL PROGRAMS

17 For an additional amount for "State and Local Pro-
18 grams" for Operation Stonegarden, \$10,000,000.
