

AMENDMENT TO H.R. 157, AS REPORTED
OFFERED BY MR. CHAFFETZ OF UTAH

Add at the end the following new section:

1 **SEC. 6. REPEAL OF OFFICE OF DISTRICT OF COLUMBIA**
2 **DELEGATE.**

3 (a) REPEAL OF OFFICE.—

4 (1) IN GENERAL.—Sections 202 and 204 of the
5 District of Columbia Delegate Act (Public Law 91–
6 405; sections 1–401 and 1–402, D.C. Official Code)
7 are repealed, and the provisions of law amended or
8 repealed by such sections are restored or revived as
9 if such sections had not been enacted.

10 (2) EFFECTIVE DATE.—The amendments made
11 by this subsection shall take effect on the date on
12 which a Representative from the District of Colum-
13 bia first takes office.

14 (b) CONFORMING AMENDMENTS TO DISTRICT OF CO-
15 LUMBIA ELECTIONS CODE OF 1955.—The District of Co-
16 lumbia Elections Code of 1955 is amended as follows:

17 (1) In section 1 (sec. 1–1001.01, D.C. Official
18 Code), by striking “the Delegate to the House of
19 Representatives,” and inserting “the Representative
20 in the Congress,”.

1 (2) In section 2 (sec. 1–1001.02, D.C. Official
2 Code)—

3 (A) by striking paragraph (6); and

4 (B) in paragraph (13), by striking “the
5 Delegate to Congress for the District of Colum-
6 bia,” and inserting “the Representative in the
7 Congress,”.

8 (3) In section 8 (sec. 1–1001.08, D.C. Official
9 Code)—

10 (A) in the heading, by striking “Delegate”
11 and inserting “Representative”; and

12 (B) by striking “Delegate,” each place it
13 appears in subsections (h)(1)(A), (i)(1), and
14 (j)(1) and inserting “Representative in the Con-
15 gress,”.

16 (4) In section 10 (sec. 1–1001.10, D.C. Official
17 Code)—

18 (A) in subsection (a)(3)(A)—

19 (i) by striking “or section 206(d) of
20 the District of Columbia Delegate Act”,
21 and

22 (ii) by striking “the office of Delegate
23 to the House of Representatives” and in-
24 serting “the office of Representative in the
25 Congress”;

1 (B) in subsection (d)(1), by striking “Dele-
2 gate,” each place it appears; and

3 (C) in subsection (d)(2)—

4 (i) by striking “(A) In the event” and
5 all that follows through “term of office,”
6 and inserting “In the event that a vacancy
7 occurs in the office of Representative in
8 the Congress before May 1 of the last year
9 of the Representative’s term of office,” and

10 (ii) by striking subparagraph (B).

11 (5) In section 11(a)(2) (sec. 1–1001.11(a)(2),
12 D.C. Official Code), by striking “Delegate to the
13 House of Representatives,” and inserting “Rep-
14 resentative in the Congress,”.

15 (6) In section 15(b) (sec. 1–1001.15(b), D.C.
16 Official Code), by striking “Delegate,” and inserting
17 “Representative in the Congress,”.

18 (7) In section 17(a) (sec. 1–1001.17(a), D.C.
19 Official Code), by striking “the Delegate to the Con-
20 gress from the District of Columbia” and inserting
21 “the Representative in the Congress”.
